

**Town of Dummer
Select Board Meeting Minutes
March 5, 2024 at 6:15 pm**

Call to Order: Chairman Ouellette called the meeting to order at 6:15 pm.

Discussion with Road Agent:

- Plan for Septic Issue: Ben reported that he inspected the vent and did not find anything but was not able to do a thorough inspection because of an elbow in the pipe. Ben suggested having somebody run a camera down the vent pipe.

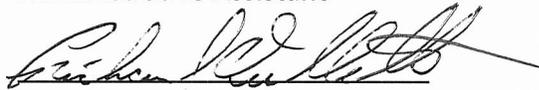
Public Participation: There was no public in attendance.
