

**Town of Dummer
Select Board Meeting Minutes
September 3, 2024 at 6:15 pm**

Call to Order: Chairman Ouellette called the meeting to order at 6:15 pm.

Review/Discuss/Sign: Invoices and Checks

Discussion with Road Agent:

- Colin and the board discussed culverts, ditching, internet in the garage, downed trees, rip-rapping, excavator rental, roadside mowing, furnace repair and garage door repair.
