Select Board Meeting Minutes  
February 25, 2025 at 6:15 pm**

**Call to Order:** Chairman Holt called the meeting to order at 6:15 pm.

**Motion to Adjourn:** Gary Dube made a motion to adjourn; Eric Demers seconded the motion; all voted in favor.


