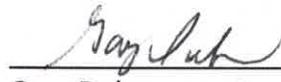
Public Participation: There was no public in attendance.

Motion to Adjourn: Eric Demers made a motion to adjourn; Joshua Ewalt seconded the motion; all voted in favor.

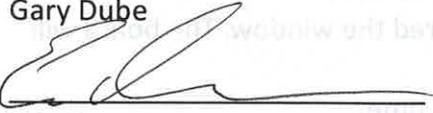
