Select Board Meeting Minutes
May 13, 2025 at 6:15 pm

In Attendance: Gary Dube, Eric Demers, Joshua Ewalt, Colin Wentworth, David Dubey, Tammi Dube

Call to Order: Gary Dube called the meeting to order at 6:15 pm.

Pledge of Allegiance:

- All present stood and recited the Pledge of Allegiance.

Review/Discuss/Sign: Invoices and Checks

Scheduled Visitor, David Dubey, 6:15:

- David Dubey, Colin and the board discussed some debris that was taken from the ditch and left on David's lawn. David would like the area restored to its previous condition. Colin reported that the State Highway Dept will be in the area around the second week of June to take care of the ditches.

Discussion with Road Agent:

- The board discussed options for replacing the Dodge.
 - Joshua Ewalt made a motion to purchase a 2025 F550 w/stainless dump body and stainless 9-1/2' plow from Nucar, using the old Dodge as a trade-in, at a cost of \$87,341, to come from the Truck CRF.
 - Gary Dube seconded. All voted in favor.

- Reimbursement from Ambulance CRF for Autotronics, LLC Invoice:
 - Gary Dube made a motion to request reimbursement from the Ambulance CRF for the Autotronics, LLC invoice in the amount of \$27,200.
 - Joshua Ewalt seconded. All voted in favor.
- NH DRA 2024 Total Equalized Valuations: The board reviewed correspondence from the NH DRA regarding 2024 Equalized Valuations.
- Driveway Permit, Bayroot R1-2: The board reviewed a Driveway Permit issued by the State of NH for a property on Route 16.
- Approval for Construction of Septic, Johnson U4-1: The board reviewed an Approval for Septic Construction issued by the State of NH.
- MS-9 Report of the Trust Funds: The board reviewed the MS-9 Report of the Trust Funds.
- Equipment East Rental Contracts: The board reviewed, approved and Chairman Dube signed the rental contracts.

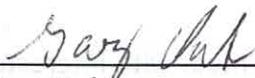

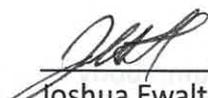
