Call to Order: Chairman Dube called the meeting to order at 6:15 pm.

Review/Discuss/Sign: Invoices and Checks

Discussion with Road Agent:

- Winter Sand Purchasing: Colin and the board discussed the purchase of winter sand. Colin will get at least three quotes for sand to be delivered from Mason Enterprises to the town property at 75 Hill Road.
- Colin will contact Mason Enterprises about shouldering (or aproning) Hawkins Road.
- Colin and the board discussed Ferry Road grading and ditching.
- Colin reported that NH DOT is planning to do ditching on Hill Road soon.
- Colin and the board discussed truck lettering and the town seal logo on the doors.



Motion to Adjourn: Joshua Ewalt made a motion to adjourn; Eric Demers seconded the motion; all voted in favor.


