Select Board Meeting Minutes
August 5, 2025 at 6:15 pm

In Attendance: Gary Dube, Eric Demers, Joshua Ewalt, Colin Wentworth, Tammi Dube

Call to Order: Chairman Dube called the meeting to order at 6:15 pm.

Pledge of Allegiance: All present stood and recited the Pledge of Allegiance.

Review/Discuss/Sign: Invoices and Checks

Discussion with Road Agent:

- Colin and the board discussed road repairs, ditching, sand, and equipment repairs. Options were discussed for roadside mowing.
- Next week, Colin will continue grading and putting calcium on the roads.
- The board approved the rental of a wheeled excavator for four weeks. It will be used for ditching and roadside mowing and is a more efficient use of town funds than paying for mowing only.
 - Joshua Ewalt made a motion to approve the rental of the excavator.
 - Gary Dube seconded. All voted in favor.

Old Business:

- Library Exhaust Fan: The board will organize a work party to install the fan and install crushed rock under the downspouts.
- Headstone Repair & Resetting: Nothing to report at this time. The board would like a quote on repairs to stones at all three cemeteries to be presented to the residents at town meeting next year.
- Town Property Sales: Nothing to report at this time.
- Kelly Brook Road Status: The board believes that this road is a Class 6 road and should not be locked. A letter will be sent to the landowner to request that the lock be removed.

- Bank Account Reconciliation: The board reviewed and signed the Bank Account Reconciliations.
- Quarterly Budget: The board reviewed the Quarterly Budget Reports.
- Correspondence from a Resident: The board reviewed correspondence from a resident regarding a garage that a neighbor is building. A building permit had been issued. The resident believes that the road and neighboring property are being encroached upon. The building inspector will be contacted.

- Emergency Operations Plan Review: The board will review at the next meeting.
