

**Town of Dummer
Select Board Meeting Minutes
November 25, 2025 at 6:15 pm**

In Attendance: Gary Dube, Eric Demers, Joshua Ewalt, Tammi Dube

Call to Order: Chairman Dube called the meeting to order at 6:15 pm.

Pledge of Allegiance: All present stood and recited the Pledge of Allegiance.

Review/Discuss/Sign: Invoices and Checks

Old Business:

- Kelly Brook Road: The board reviewed a complaint that has been filed against the town regarding the status of Kelly Brook Road. The board will consult with the town's attorney.

New Business:

- Logging Truck on Blake Road: The board discussed overweight vehicles on Blake Road. The board will draft a template letter to be sent to violators. The board discussed putting signs such as 'no through trucks' or 'local deliveries only.' The board discussed the legality of using a camera to aid in enforcement. The board members will reach out to other local departments (sheriff, other select boards) to discuss enforcement issues.
 - Joshua Ewalt made a motion to put up signs.
 - Eric Demers seconded. All voted in favor.
- Tax Warrant: The board reviewed and signed the 2025 2nd Issue Tax Warrant.
- MS-60-W: The board reviewed and signed the 2025 MS-60-W, Audit Waiver Request.
- Town Hall Rental: The board reviewed and approved a Town Hall Rental Agreement.
- MS-9 Report of the Trust Funds: The board reviewed the MS-9 Report of the Trust Funds.
- Dummer Conservation Commission: The board reviewed correspondence and draft bylaws submitted by the Conservation Commission.
- Dummer-Milan Library
 - Correspondence from Attorney: The board reviewed correspondence from the town attorney regarding the merger of Dummer and Milan libraries. The board agreed to sign conflict waivers that are required because the towns of Dummer and Milan use the same legal firm.
 - MOU Addendum: The board reviewed an addendum to the MOU submitted by the library trustees.
- Budget: The board reviewed the 2026 budget and set some preliminary numbers.


